MSP(Price/Call) IMD will have a standardized late entry fee of \$10.00. This fee will be put in place 1 week prior to the first race. Athletes that are notified that they are eligible for the race after the late entry fee deadline will not be subject to a late fee. In addition, if a race organizer has a compelling reason to refund a late entry fee, then it will solely be up to the organizer.

Development Committee Discussions

- All Regular season race will be based on a gender split to accommodate the 100 athletes per venue per day
- The exception will be the South Series. The South Series has too many athletes to do a gender split. The South Series will be split by teams
- There will be a Tri-Divisional event for U16 athletes with Alaska and Northern. The event will be in Big Sky.
- There is discussion about having a two-tiered IMD Championships and splitting the field based on rank.
