Release of Liability:

In consideration for the rights and privileges associated with participation in the North Series Race hosted by the McCall Winter Sports Club (MWSC), I acknowledge and agree to be bound by the following:

Identification of Risks.

I understand that my participation in any skiing activity including the North Series Race, involve risks of serious injury, including permanent disability, death and other losses, both to me and my property. I understand that these injuries and losses might result not only from my actions but the actions inactions or negligence of others.

Assumption of Risk.

I agree that I am responsible for my child's safety while participating in the North Series and that such responsibility includes participation in the Race only: A: when my child is both physically and psychologically prepared to participate safely, B: my child is fully familiar with the venue before beginning the race, and C: my child is using the equipment of a type and condition reasonably necessary to safely participate in the Race. I assume all the risks and responsibilities for any injury or loss connected with my child's participation. As the parent or guardian of the minor racer named below, I hereby make and enter into each and every agreement, representation, waiver and release described above on behalf of myself, the athlete, and any other parent or guardian of the athlete, intending that they be binding on me, the athlete, and our respective heirs, executors, administrators and assigns. I intend to give up my right, the athletes right, and the right of any other parent or guardian to maintain any claim or suit against the McCall Winter Sports Club (MWSC) or Brundage Mountain Resort arising out of the athletes' participation in any Activities involving MWSC and Brundage in any way. I believe and represent the I HAVE LEGAL AUTHORITY TO MAKE THESE AGREEMENTS, REPRESENTATIONS, WAIVERS AND RELEASES, AND I AGREE TO DEFEND AND INDEMNIFY MWSC and Brundage from and against any and all liability arising out of any lack of authority on my part to legally bind the Racer, or any unenforce-ability for any reason of the above agreements, representations, waivers and releases made by or on behalf of the Racer.

Insurance:

I currently have and agree to maintain throughout the time that my child trains and competes, valid and sufficient medical and accident insurance. I understand that this is my sole responsibility and release all persons and entities from providing this coverage for my child. This is to certify that, as the participant or the parent/guardian of the above named minor; I do hereby acknowledge and consent to my or his/her agreement to be bound by each of the terms and conditions identified above.

Medical Release:

I do hereby authorize any licensed physician and/or responsible staff member of any hospital in any state to administer whatever medical treatment, or therapeutic procedures they deem necessary for the diagnosis and treatment of the child named below:

Photo Release:

The McCall Winter Sports Club has my permission to use my or my child's photograph publicly to promote the Club. I understand that the images may be used in print publications, online publications, presentations, websites, and social media. I also understand that no royalty, fee or other compensation shall become payable to me by reason of such use. My name or my child's name will not be used without prior written consent.
