- I agree to forever waive and release **Brian Head Resort** from any and all claims, including any **negligence on the part of Brian Head Resort** and injuries, losses, and damages resulting in any way from my association with, entry in this event or participation in this event’s training, practice, or competitive events and clinics. My release includes all claims regarding the design or conditions of event site, course, structures or equipment utilized by me in training, practice, or competitive events or clinics and any claim for express or implied warranty. I agree to indemnify and hold **Brian Head Resort** harmless from all claims, damages or injuries related to my participation in the event, training, practice or clinics, including reimbursement of any attorney’s fees and costs incurred by **Brian Head Resort** even if **Brian Head Resort** is negligent.
